Die Einreisekarte für Mexiko besteht aus zwei Teilen – dem **Einreise-** und dem **Ausreiseformular**. Beide Teile müssen von jedem Reisenden in Druckbuchstaben ausgefüllt werden. Eine Zusammenfassung von Familien oder Gruppen auf einer Karte ist nicht möglich. Wichtig: Nicht vergessen, im dafür vorgesehenen Feld zu unterschreiben! Zusätzlich muss von jedem Passagier bzw. von einer Person pro Familie die Zollerklärung ausgefüllt werden. Die Einreisekarte wird dem Beamten bei der Ankunft am Flughafen ausgehändigt. Dieser trennt die Einreise- und Ausreisekarte und überlässt die Ausreisekarte dem Reisenden zur Verwahrung während seines Aufenthalts. Bei der Rückreise wird die Ausreisekarte abgegeben. Achtung: Der Verlust der Karte verursacht eine Geldstrafe.
